

MINIBUS AND LARGE MPV QUALIFICATION & COVER RESTRICTIONS - CHECK BEFORE HIRING

IN ADDITION to our Standard Qualification & Cover restrictions, we have specific rules that apply to ALL vehicles with more than 8 seats (including the driver) up to the current maximum for the scheme of 17 seats (including the driver).



QUALIFYING DRIVERS

- For ALL vehicles with more than 8 seats and up to 17 seats (including the driver).
Age limits 30 to 70 with 5 years driving experience on a full licence

Drivers outside the above requirements will **NOT** be insured unless a request has been made to the Insurance Department or your Regional Sales Manager and the appropriate authorisation code has been given for inclusion on the rental agreement.



LICENCES

- For vehicles up to 9 seats (including the driver)
Normal car licence (category B on UK and EEC card licence) is acceptable
- For vehicles over 9 seats and up to 17 seats (including the driver)
Hirers from the UK and EEC must have category D1 (minibus) or better – **under no circumstances** will we insure minibuses out to hirers without D1 (UK and EEC only)
- For drivers from foreign countries other than EEC
Hirers can only legally drive up to 9 seats (including driver) in the UK – **we will not therefore insure foreign drivers (other than EEC with category D1)** for vehicles over 9 seats (including the driver)



EXCESSES & DEPOSITS

- Minimum damage excess of £1000
- Licensee is liable for the first £1500 of all claims
- Deposit level - 50% of excess minimum deposit + cost of hire up front on a debit or credit card
- No cash hires



USE OF VEHICLE EXCLUSION

- No hire or reward



CUSTOMERS OWN INSURANCE (COI)

- Where customers own insurance is used, there must be a valid certificate of insurance (copy to be kept with rental agreement)
- The Licensee must confirm insurance is valid for their hire vehicle
- Only corporate allowed – no private motor policies.



AGE OF VEHICLES

- Any minibus added to the fleet must be less than 7 years old
- Existing minibuses over 7 years old must be removed from the fleet



FOREIGN TRAVEL – Vehicles with over 9 seats (including the driver) must have a tacograph fitted to be insured for foreign travel. We will issue a 'Green Card' for the following countries – you will need to check countries to be visited/travelled through and call Insurance Department if the country is not listed:

Austria, Belgium, Denmark, Finland, France, Germany, Greece, Hungary, Italy, Luxembourg, Netherlands, Norway, Poland, Portugal, Spain, Sweden, Switzerland
